Limited tenders for Construction of Two Tube Wells at Haripura village (Sirohi Road) Agri. farm of COA, Jhilai (Tonk) are invited in sealed envelopes as per following terms and conditions:

1. The rates should be quoted F.O.R. COA Jhilai farm otherwise cost of packing, forwarding, freight, installation etc. be given. No extra amount will be paid other than quoted amount in bid.
2. The tender must reach to this office on or before 05-07-2024 up to 01:00 PM.
3. Rate for tender premium quoted should be inclusive of all taxes and charges. No extra payment will be made for tax/duty/royalty or other charges.
4. The committee reserves the right to reject the tender without assigning any reason thereof.
5. Tender for Construction of Tube Well at Haripura village (Sirohi Road) Agri. farm of COA, Jhilai (Tonk) should be mentioned on the top of sealed envelope addressing **Dean, COA, Jhilai-Niwai, Tonk (Rajasthan)**.
6. The prices should be typed or written clearly in ink against each items. Cutting should be avoided as erroneous and overwriting are not permissible.
7. The specification as per **Annexure-1** should be fulfilled for **Construction of Tube Well at Haripura Agri. Farm of COA Jhilai**.
8. The terms and conditions should be read carefully and each page of the tender should be signed and sealed properly.
9. The billing for these items should be made in favour of "**Dean, COA, Jhilai-Niwai, Tonk**".
10. The tender form should be filled as per given terms and conditions.
11. Self-attested copies of Address proof, PAN Card, GST Registration, Firm Registration and other essential certificates as required must be attached while submitting the tender.
12. Bids should be duly signed on all pages and serially numbered, properly bound.
13. Contract (Terms & Conditions) Tender document can be collected from office on all working days upto on 05-07-2024
14. Please read and understand the terms and condition carefully. Also you are requested to visit the institute during the working hours to get clear idea about the work.

16. Write "**Construction of Tube Well**" on the envelope.
17. The technical bid shall be opened first and only the eligible Vendors selected by Committee shall be considered in the financial bid which shall be opened on a date further fixed by the Tender Committee. The committee may decide to visit any or all sites as given by the bidder.
18. The work should be completed within 10 days of order.
19. The responsibility of GST/other charges etc. as per govt. rule will be borne by supplier.

24. For reason beyond the control of the contractor, the university authorities may grant extension of the time for the period as considered reasonable.
25. If the contractor fails to commence the work within 10 days of the receipt of the work order it shall rest with the University to forfeit his earnest money.
26. Any conditional tender will not be accepted.
27. The contractor before submitting their terms and condition to execute the work must carefully go through the prescribed contract agreement of the University successful tenderer shall be required to enter into an Agreement with the University as per general conditions laid therein.
