Terms and Conditions for installation of Low cost structure

- 1. The tenderer shall quote rates, which will include the delivery (supply and installations) & other incidental charges. Taxes, if any, should be indicated separately.
- 2. Nature and amount of security deposit: A total security deposit of Rs 8000/- will have to be deposited through banker cheque/demand draft.
- 3. Tender form can be obtained from the office by depositing Rs 590/- or it can be download from the website and attach a DD/BC of Rs.590/- separately for the fee of tender form.
- 4. The rates should be quoted as per the Financial Bid. Taxes, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfils all the required specifications, terms and conditions and remains L-1.
- 5. The firm must also possess valid PAN No., & GST registration number and a copy of the same must also be enclosed with the tender document.
- 6. The firm must attach last 3 year turnover statement.
- 7. Copy of Income Tax Return of last 2 years may be furnished.
- 8. Modification in the tender documents after the closing date and time is not permissible.
- 9. The successful firm shall have to supply the **item and work completion** (from the date of confirmed supply order) **within 45 days /as mentioned in the supply order)** and if the materials are not supplied and installed in time then EMD shall be forfeited. The rates quoted shall be valid for 3 months from the date of opening of tender.
- 10. The contractor/bidder or his representative may contact the undersigned for any further clarification. No variation in terms of quality of the items shall be entertained or else EMD/Security deposit shall be forfeited.
- 11. The Director, RARI, Durgapura shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job.
- 12. Merely quoting of lowest rates does not mean that order shall be given to that firm. The competent authority will finally decide on the basis of quality & performance of past installations.

- 13. The interested Firms are required to deposit/submit (in original) an Earnest Money Deposit (bid Security) @ of 2 % cost of the tender amount in the form of Demand Draft/Bankers cheque/Pay order from any of the Commercial Bank in favour of "The Director, RARI, Durgapura", payable at Jaipur on or before bid submission closing date and time as mentioned in tender document. No quotation/tender shall be considered without the earnest money deposit. Demand Draft drawn in favour of any officer other than "The Director, RARI Durgapura" payable at Jaipur' will not be accepted and the tender will be rejected. The earnest money will be refunded only after the finalization of the procurement and no interest will be paid on earnest money.
- 14. Rates once finalized will not be enhanced/reduced during the currency of the contract. In case of foreign currency, conversion rates in INR will be taken on that day when financial bid will open.
- 15. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason(s), to honour the contract, the earnest money deposit would be forfeited.
- 16. The Director, RARI Durgapura reserves the right to cancel the contract at any time during the currency period of the contract without giving any reason.
- 17. If any dispute(s) arises between The Director, RARI Durgapura and the firm with reference to the contract, The Director, RARI Durgapura will decide it and its decision will be binding on the firms.
- 18. Bid Validity: 90 days.
- 19. The contract will be given to lowest bidder (L1) and Firm will be responsible for one year maintenance after installation the structure.
- 20. **Payment-** 100% of the contract price on completion/ installation as per specifications by successful bidder.
- 21. Installation: Should be done within stipulated delivery period as per the order at the location as mentioned in the tender in consultation with the indenting officer.
