




Evaluation of Technical Bid of e-tender of Laboratory Equipments, SKNAU-Jobner





Therefore the committee recommends that all the firms from serial No. 1 to serial No.6 technically non-responsive as they have not submitted essential documents as stated in table. Hence the committee recommends to revoke the e-tender.
