Terms and Conditions

1. **Technical and financial bids are to be prepared separately in two envelopes.**
2. Important annexures/documents except financial bid should be kept in **Envelope 1** along with tender fee DD if not already paid to this office and earnest money DD.
3. **Envelope 2** should contain only financial bid and it will be opened only when technical bid of the bidder is qualified.
4. If technical & financial bids are not given separately, it will be rejected without assigning any reason.
5. The Bidder has to **clearly mention make and model name** of all the items in the technical bid.
6. The rate quoted shall be inclusive of delivery, installation and demonstration at the College of Agriculture, Peethampuri (Sikar).
7. The firm should have a **minimum average turnover of 50 lacs for the last three financial years duly certified by CA.**
8. The FOR at College of Agriculture, Peethampuri-Neemkathana.
9. **Current Authorization letter/certificate** issued from Manufacturer/Principal Firm whichever is applicable.
10. **Supply and user satisfactory certificate for Interactive Flat Panel and Vertical Standee signage to Govt. institutes to be attached (Minimum two).**
11. The Bidder should undertake to provide after sale service whenever needed by the purchaser.
12. **Delivery and installation within 07 days after receipt of work order.**
13. Earnest money will be returned to the non-successful bidder after finalization of the tender. Successful bidders will have to deposit 5.0% performance security (of order value) that will be returned after satisfactory completion of warranty period of each supplied item.
14. Self-attested copy of GST/PAN/C.S.T. Nos. may be attached with the bid.
