

4. If technical & financial bids are not given separately, it will be rejected without assigning any reason.
5. The rate quoted shall be inclusive of delivery at the Krishi Vigyan Kendra, Arnia, Sri Madhopur (Sikar-II).
6. The tenderer must put his **signature and stamp on every paper** of tender including terms and condition.
7. Earnest money will be returned to the non-successful bidder after finalization of the tender. Successful bidders will have to deposit 5.0% performance security (of order value) that will be returned after satisfactory completion of warranty period of each supplied item.
8. Self-attested copy of GST/PAN/C.S.T. Nos. may be attached with the bid.
