- 1. The committee recommends to approve the purchase of article No. (3, 7, 8, 12, 14, 15, 16, 18, 23, 25, 30, 35, 36, 46, 49, 50 from the Firm M/S Biomole India) and article No. (5, 6, 9, 13, 21, 22, 52 from the firm M/s Vedant Sales Corporation) as above.
- 2. The Item which were found quoted only by single firm the committee discussed and after negotiation it was found that:
 - a) The bid is technically qualified.
 - b) The price quoted by the bidder is assessed to be reasonable.
 - c) The bid is unconditional and complete in all respects
 - d) There are no obvious indicators of cartelisation amongst bidders and
 - The bidder is qualified as per the provision of section 7.

The final prices are competitive and as per market prevailing rates, hence the committee recommend to purchase the items as per university rules.

- 3. The price of the article at Sr. No. 17, 26, 27 & 28 were quoted on a very high price, hence committee recommends to reject the purchase of the items.
- The price of the article number (1, 2, 4, 19, 20, 29, 31, 32, 33, 34, 37, 38, 39, 40, 41, 42, 43, 56, 57, 58) were quoted on high price/ not negotiated, hence 44, 45, 47, 48, 51, 53, 54, committee recommends to reject/ not approved for the purchase of the items.
- The rates for the article no. (24, 55) not quoted by any of the firms
- The items mentioned at Sr. No. 10 & 11 have not permission to purchase. Therefore committee recommend not to purchase the items.
