

Terms & Conditions and Instructions:

1. The term of the office of the Vice- Chancellor shall be **three years** from the date on which he/she enters upon his/her office or until he/she attains the age of **seventy years**, whichever is earlier. The Vice- Chancellor shall receive such pay and allowances as may be determined by the State Government.
