The committee, after due analysis and negotiation, recommends the lowest eligible bids of the above technically qualified bidders for item No. (1 to 8 and 10 to 13) for procurement as per the tender specifications and conditions, for approval and rejected item no. 9 i.e. Online ups-20KVA with 60 min backup due to higher price quoted even after negotiation than the estimated price and also rejected item No. 14 Photocopier (Colour) due to firm M/s Abhinav Digital & Interior Solutions Pvt. Ltd did not negotiate on price and put the condition to supply trolley, if all the quantities are single ordered which the committee rejected. The committee also recommended to rebid item no. 9 and 14 separately.

The committee also certifies the following points for single bid received for AIO (i5) Desktop Systems, Multi-Function Printer (MFP Black & White) Inktank, Heavy duty MFP (All-in-One Duplex InkTank Printer) and Digital Signage-55" as per rule no 68 of RTPP Rules 2013

- (a) the bid is technically qualified;
- (b) the price quoted by the bidder is assessed to be reasonable;
- (c) the bid is unconditional and complete in all respects;
- (d) there are no obvious indicators of cartelisation amongst bidders; and
- (e) the bidder is qualified as per the provisions of section 7

Further all the rates recommended are as per market prevailing rates.
