Party No.2 Navya Enterprises, 31-II floor, Narayana Ind. Area, Phase I, New Delhi,-110028, uploaded ISO and other certificates which could not be verified. Hence all the above firms i.e. Party No.1, Party No.2, and Party No.3 were disqualified.

The remaining firms viz., Party No.4, Shri Vinayak Trading Company, 24, Sitapuri Colony, Sikar Road, Jaipur, Rajasthan, 302013, Party No.5 Vinayak Enterprises, Jato ka Mahala, Ram Nagar Dhani, Kishangarh, Ajmer, Party No.6 Vinayak Trading Company, 77, Maa Hinglaj Nagar, Lalarpura, Jaipur-302021 are technically qualified.

So committee recommends opening the financial bids of these firms on 03.09.2025 at 11:00 AM.
