1	U-Shape Conference Table	 Providing and fixing U-shaped conference table: The top of all the seats is made of 25mm thick edges in MDF pre-laminated particle board having all edges covered with 2mm thick PVC edge banding applied to the edges with edge banding glue heated using edge banding machine. The gable are in 18mm thick MDF pre-laminated particle board and modesty of the conference table are made in 18mm thick MDF pre-laminated particle board having all edges covered with 2mm thick PVC edge banding applied to the edges with edge banding glue heated using edge banding machine. A cable tray made in MS CRCA sheet of 0.8mm is provided at all seats. The MS components are duly powder coated with powder coated thickness of 60 microns. The completed table is assembled using minifix, dowel and other required fittings. Adjusters are provided below the table to prevent any scratches on the floor. Two corners of size 600mm×600mm (±10) in curvature should be installed along with these. Popup Box for conference table: Dimension: Minimum 300mm×100mm Ports: Minimum 6 (including universal power socket, LAN cat-6, HDMI 4k, VGA, USB, charging port, microphone etc.) All wirings and connections, if required
