Walk-in-Interview for engagement of Young Professional (YP-II) on contractual basis under the NATIONAL INNOVATION ON CLIMATE RESILIENT AGRICULTURE (NICRA) Project funded by Govt. of India will be held at Training Hall, Krishi Vigyan Kendra, Kumher- Bharatpur, on 27.10.2025 at 10.30 A.M. Date and time of Interview: 27.10.2025 at 10.30 AM.

Venue: Training Hall of Krishi Vigyan Kendra, Kumher-Bharatpur

Terms and conditions: -

1. The selected candidate will be required to be given an under taking that he/she will not leave the assignment half-way and shall complete the work in the prescribed time limit.
2. Age Limit: - The age limit is Minimum 21 years & Maximum 45 years with relaxations applicable as per rules and regulation of Govt. of Rajasthan.
3. The placement of Young Professional YP-II in the scheme/project will be made on contract basis.
4. Candidates called for the interview will not be entitled for TA/DA.
5. The position will be terminated on completion of the terms of the scheme/project whichever is earlier. KVK/University holds no responsibility for his regularization/ appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporarily, time bound arrangement on co-terminus basis with the project.

6. The appointment will be terminated at any time by issue of 24-hour notice if the candidate found to be negligent in his/her work or found guilty of gross negligence in his/her duties or grave misconduct.
7. Candidate will be under the administrative control of the concerned Senior Scientist & Head, Krishi Vigyan Kendra, Kumher, Bharatpur.
8. The candidate shall settle his claim within one year of leaving scheme and no claim will be entertained after one year of leaving or termination of his/her service.
9. The research work done by the candidate will be the property of KVK and candidate will have no control or right on the same. The contribution in research work can accordingly be acknowledged /included in the research papers after the prior permission from PI.
10. Candidate will devote his/her whole time to assignment given to him/her and he/she will not allow to accept or hold another appoint paid or otherwise during that period.
11. Candidate shall not leave project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
12. The candidate has to perform all duties, responsibilities that will be assigned to him/her by the PI/CO PI/Authority as per the requirement of the project.
13. The candidate selected for the post will have to execute a bond on a Rs 100 stamp paper as per University Rules.
14. The candidate should apply on plain paper in own handwriting giving full details as per the enclosed Proforma to Senior Scientist & Head, Krishi Vigyan Kendra, Kumher, Bharatpur – 321201 on or before 27/10/2025.
15. The eligible candidate will be interviewed by the selection committee. The applicants will have to appear for interview on schedule date and time at their own cost.
16. The selected candidate will have to work at the. Krishi Vigyan Kendra, Kumher, Bharatpur in the field as well as in the laboratory also farmers field for the entire terms as fulltime assignment during this period.
17. The notification does not mean that the post will be necessarily filled. The discretionary powers will rest with the selected candidate for the said post shall be tenure appointment and likely to be terminated at any time without assigning any reason there of and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of this appointment.
18. Last date for reaching the applications is on or before 27/10/2025 application after last date/postal delay will not be considered.
19. The appointment shall be initially up to March 31, 2026 or till the duration of the project whichever is earlier and extendable on year-to-year basis depending upon the performance of the candidate and sanction received from funding Agency. Thus, maximum duration of engagement of YP-II is three years (1+1+1) as per ICAR guidelines or approval of the project.

21. Remuneration will be paid after receiving fund from funding Agency/ ICAR.
22. Selected Candidate Join the post within 7 days issuing of Appointment Order otherwise their candidate will be treated as cancelled and next candidate in waiting list will be considered.
23. If number of applications to the post are more than 20 in that case written examination may be conducted by the selection committee, the questionnaire will be relevant to the project.
24. Preference will be given to those candidates having experience in the same project as per format enclosed. A computer based test will be conducted at the time of the interview.
