

3. The responsibility of GST/other charges, tax etc applicable as per Govt. rule will be borne by the supplier.
4. GST and PAN copies are to be enclosed with tender.
5. The firm should deposit 2 % Security or **EMD Rs.3,500/-** amount with tender documents.
6. The value of the work order against this tender will be maximum **Rs 1,74,700/-**
7. No advance payment will be made to the tenderer and the money will be released only after satisfactory completion of work i.e. supply, installation and verification.
8. Any lapse in time may lead to action against the tenderer under RTPP 2012, RTPP 2013 and other rules laid down by Rajasthan Govt. from time to time and the penalty (L.D.) will be charged.
