## **Terms and Conditions**

1. **Technical and financial bids are to be prepared separately in two envelopes.**
2. Important annexures/documents except financial bid should be kept in **Envelope 1** along with tender fee DD if not already paid to this office and earnest money DD.
3. **Envelope 2** should contain only financial bid and it will be opened only when technical bid of the bidder is qualified.
4. If technical & financial bids are not given separately, it will be rejected without assigning any reason.
5. The Bidder has to **clearly mention make and model name** of all the items in the technical bid.
6. The rate quoted shall be inclusive of delivery and installation/demo at the College of Agriculture, Peethampuri (Sikar).
7. The approximate quantity of purchases may be increased or decreased.
8. The firm should have a **minimum average turnover of 15 lacs for the last three financial years duly certified by CA.**
9. The FOR at College of Agriculture, Peethampuri-Neemkathana.
10. Current Authorization letter issued from Manufacturer/Principal Firm whichever is applicable.
11. Delivery within **20 days** after receipt of work order.
12. Earnest money will be returned to the non-successful bidder after finalization of the tender. Successful bidders will have to deposit 5.0% performance security (of order value) that will be returned after satisfactory completion of warranty period of each supplied item.
