2. The tender must reach to this office on or before 04.03.2026 up to 01:00 PM.
3. The ordered work will have to be completed within time frame of placing the orders.
4. All taxes and excise duty if any to be charged extra should be mentioned clearly.
5. The undersigned reserves the right to reject the tender without assigning any reason thereof.
6. The undersigned reserves the right to procure quantity and give orders of the mentioned tendered items as per requirement.

The upper diameter of the funnel should be 125 mm and the bottom diameter should be 45 mm and the height should be 100 mm. The upper edge of the funnel should be tapered so that the beetle cannot sit on the funnel. 4. Vertical plate height should be 130 mm.
2.	Pheromone Lure	1000	<ol style="list-style-type: none"> 1. The lure case should be made of LD plastic- fitted in the vertical plate. 2. Lure should consist of plastic vial and should be fitted in the Lure case. The vial should be 3 ml capacity. 3. The lure manufacture under the guidance of AINP on SAP & NBAIR, Bengaluru with trade name ‘Shatpada’ white grub lure.

Special Terms & Conditions

1. Brand should be registered in India.
2. The Bidder shall quote only one specific make and model from only specific OEM. Providing more than one option shall not be allowed.
3. The OEM for all active components should give a declaration that products or technologies quoted are neither end-of-sale nor end-of life as on the date of installation and commissioning and are not-of support till the warranty period.
