

The open sealed tender was invited to supply of Electronic Items (RO, Water Cooler & Refrigerator) at College of Agriculture, Fatehpur-Shekawati, Sikar, Rajasthan vide tender No. F. (41)/Store/COA/FTR/2025/2583; Dated: 31.12.2025. The tenders were opened on 08.01.2026 at 12.30 PM in the presence of the sale and purchasing committee members. Total five parties submitted bids are namely as under; Party No. 1. (Priya Enterprises, Near Govardhan Plaza, Gurjar Bhawan Ki Piche, Kotputli), Party No 2. (Priya Electronics & Ele, Near Nagar Palika Park, Kotputli, Rajasthan-303108), Party No 3. (Kejriwal Industries, Near GB Modi School, Station Road, Jhunjhunu, Rajasthan, 333001.), Party No 4. (Sara enterprises, Ratangarh Road, Salasar, Churu, Rajasthan-331506), and Party No. 5. (B. R. Construction company, ward no. 33 Fatehpur-Shekawat, Sikar, Rajasthan- 332301) The bids submitted by the above firms were critically evaluated by the committee as per the eligibility criteria, and terms & conditions specified in the tender documents. The technical bids were evaluated as per required G- Schedule for the **supply of Electronic Items (RO, Water Cooler & Refrigerator)**. Based on the technical submitted by above mentioned parties, all five parties (Party No. 1. (Priya Enterprises, Near Govardhan Plaza, Gurjar Bhawan Ki Piche, Kotputli), Party No 2. (Priya Electronics & Ele, Near Nagar Palika Park, Kotputli, Rajasthan-303108), Party No 3. (Kejriwal Industries, Near GB Modi School, Station Road, Jhunjhunu, Rajasthan, 333001), Party No 4. (Sara enterprises, Ratangarh Road, Salasar, Churu, Rajasthan-331506), and Party No. 5. (B. R. Constriction company, ward no. 33 Fatehpur-Shekawat, Sikar, Rajasthan-332301.) are responsive for the supply of Electronic Items. However, party no.04 (Sara enterprises, Ratangarh Road, Salasar, Churu, Rajasthan-331506) is responsive only for supply of RO. Therefore, the committee recommends to opening the financial bids of all five parties (Party No.01, Party No 02, Party No. 03, Party No. 04 & Party No. 05) except, party no. 04 for which only RO rate will be compared in financial bids. The financial bids are opened on same day (08.01.2026) at 4:00 PM
