Sealed tenders are invited from the reputed firms for the supply of "2 Seater Student Bench" as per the details given below in two bid system (Technical Bid & Financial Bid). The tenders will be accepted up to **10.30 AM on 04.03.2026** and will be opened at **11.30 AM** on the same day at SKN College of Agriculture, Jobner. Bid document can be obtained from this office by depositing bid document fee in cash **Rs. 500** and also downloaded from the university website www.sknau.ac.in & sppp.rajasthan.gov.in and will have to submit DD or banker's cheque **Rs. 500** in favour of Dean, SKN College of Agriculture, Jobner while submitting bid. **Earnest money of Rs. 10000/-** in the form of DD or banker's cheque will be deposited in favour of the Dean, SKN College of Agriculture, Jobner as per RPPP rules failing which the tender will not be accepted. Approximate cost of bid purchase of item is **Rs. 5,00,000 lakhs for 2 Seater Student Bench, including all taxes and FOR Jobner**. The approximate purchasing can be **increased/decreased**.

Terms and Conditions

1. **Technical and financial bids are to be prepared and submitted separately in two envelopes.**
2. Important annexures/documents except financial bid should be kept in **Envelope 1** along with tender fee DD if not already paid to this office and earnest money DD.
3. **Envelope 2** should contain only financial bid and it will be opened only when technical bid of the bidder is qualified.
4. If technical & financial bids are not given separately, it will be rejected without assigning any reason.
5. The Bidder has to **mention make and model name** of all the items in the technical bid.
6. The rate quoted shall be inclusive of delivery and installation at the SKN College of Agriculture, Jobner.
7. The bidder should submit Current Authorization letter issued from Manufacturer/Principal Firm whichever is applicable.
8. Delivery within **15 days** after receipt of work order.
9. Earnest money 2% of approximate cost will be deposited by each tenderer as per RTPP rules.
10. Earnest money will be returned to the non-successful bidder after finalization of the tender. Successful bidders will have to deposit 5.0% performance security (of order value) that will be returned after satisfactory completion of warranty period of each supplied item.
11. Self-attested copy of GST/PAN/C.S.T. Nos. may be attached with the bid.
12. In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at Jaipur.
13. No advance payment will be made to the tenderer and the payment will be released by treasury office SKNAU Jobner only after satisfactory completion of work i.e. supply, installation and verification by the purchaser.
14. The tenderer must put his **signature and stamp on every paper** of tender including terms and condition.
15. Lowest price quoted will not qualify for selection of tender but quality and desired standards will also be considered.
16. Tender will not be considered if bidder fails to submit the security deposit and tender fee.

Specification in Details

- Dual Desk :- W 1066mm x D 930mm x H760/460mm Side frame structure: Made of prime quality Cold Rolled Close Annealed (CRCA) pressed form section 95mm x 25mm x 1mm thick welded to 25mm x 50mm x 1.2mm (18 gauge) thick CRCA tube.
- Seat and back side frame structure also made of prime quality CRCA pressed form section 95mm x 25mm x 1mm thick welded to 25.4mm diameter x1.2mm thick Electric Resistance Welded (ERW) pipe.
- Dual-seater integrated bench with backrest and connected desk, designed for comfort and posture support.
- Under-desk shelf for books and bags.
- There should be eight horizontal supports of 25mm x 25mm x 1.2mm (18 gauge) thickness and shall be CRCA tube.
- Rectangular tube 50 x 25 x 1.2mm (18 gauge) thick and the back pipe dia. 25.4 x 1.2mm should be closed with Polypropylene Copolymer (PPCP) caps at both the ends.
- OEM will ensure that there should be no rough surface/sharp edges at the closed ends.
- Front panel and tray shall be made of prime quality 0.8mm thick (21 gauge) CRCA sheet. Front panel should be of H150mm and width should be appropriate to the size of the worktop. Front Face must be embossed.
- Tray/shelf should be with 250mm-300mmD.
- There shall be no sharp edge. One vertical support (partition) of square tube size 25mm square x 1.2mm thick must be provided at center of tray.
- Desktop, seat and back shall be made of an overall 18mm thick panel made of Pre-Laminated Particle Board (PLPB) and edges must be sealed with 2mm thick PVC edge



banding tape with hot melt glue on edge banding machine. Edge band must be trimmed on edges and corner, for Sizes as below:-

- All Pipes shall be of ERW-1, ISI marked.
- All MS. CRCA parts must be MIG, TIG welded. The welding should be continuous and smooth without leaving any sore holes. All steel components must be powder coated followed by 7 tank anti- corrosion treatment of surface.
