With reference to the Notice Inviting Bid for Supply & Installation of 60 kW Solar System at College of Agriculture, Baseri, Dholpur, we respectfully submit the following for your kind consideration.

In the approved make list of Solar Photovoltaic Modules, the make “INS Solar” has been mentioned. However, no recognized PV module manufacturer or model structure is available in the market under the standalone name “INS Solar”. Such mention may create ambiguity during technical evaluation.
